	Demand Draft, no other mode will not be entertained as RTI application fees. No fee shall be

	without requisite fees it will be treated as incomplete application.
7.	Processing charges of Rs. 300/- per paper is payable through a Demand Draft/ Banker's
	Cheque drawn on any nationalized Bank in favour of "West Bengal State University" or
	University challan after getting intimation from the RTI Cell of the University.
